Mrs. Isaacson started the Principal's Report:

- Everything has been going well here.
- Working on scheduling for next year.
- NTC will be here next week to meet with Sophomore and Junior Students.

Mr. Bergman continued the Report:

- Chrome Books are in will now be 1 on 1 For Elementary Students.
- Have gotten lap tops also, they will be going out in the next couple weeks.
- Grant for the Elementary robots has been received, there will be a total of 20.
- Doing the Teach the Teacher program, a grant was received last year.

The Bargaining Committee met with the Teachers Group regarding 2021-2022 Teacher CPI Increases. Handed out is what the Teachers Group came up with. The breakdown differs from what the Committee was proposing. The dollar amount was the same. The committee's recommendation is to go with the Teachers proposal.

Mr. Bergman talked about staffing for the 2022-2023 School Year. The District will need all the staff we currently have. One additional Elementary Teacher may be needed, depends on what happens. May need to extend time for the school day. This would be time needed to have a smoother transition between lunch groups. This year the High and Middle School are very tight on instructional hours needed. Any more lost days will require make up days.

Handed out was the OPEB (Other Post-Employment Benefits) Report. This covers all the details of what needs to be done regarding retirement.

The proposed CESA 10 Services Contract 2022-2023 was discussed. CESA 10 is where all the Districts Accounting functions occur.

Motion Blomberg, second Carlson to approve the CESA 10 Shared Services Contract 2022-2023. Carried

Wendy Sielaff was appointed as the Northern School District Trust Delegate.

Handed out and reviewed was the Achievement GAP Reduction Performance Objectives and School Board Reporting Template. Great gains have been made by all students. There was catching up to do after last year's covid time away from school. Hopefully with covid gone can work on getting students to attend as they should. Some students have not been attending when they should have been. Need to be able to do a better job with attendance next year.

Motion Palmquist, second Carlson to approve Jordan Freund as the 2022 Wisconsin Technical Excellence Award Recipient. Carried
